

# **MEMBERSHIP**


CAAR membership and member value remain the top priority of the CAAR board of directors and staff.

# **ADVOCACY ACTIVITIES**

CAAR continues to work directly with federal and provincial regulators and partners with agriculture associations ensuring the uninterrupted business of ag retailing.

### **Activities include:**

- Transport Canada Hours of Operation, agriculture commodity movement, ag retailers
- Transport Canada Agriculture commodities identified as essential during rail blockades and strikes. Resolve disruptions
- Transport Canada Equivalency and temporary certificates relating to ammonia nurse tanks
- Provincial Premiers and Ministers of Agriculture Agriculture commodity movement across borders identified as essential and ag retail business function during COVID-19 pandemic
- Prime Minister and Federal Ministers Agriculture commodity movement across borders identified as essential and ag retail business function during COVID-19 pandemic
- CSA B620/622 updates

# REGULATORY COMPLIANCE

CAAR's remains committed to regulatory compliance support for its members and continue to update compliance courses and programs every year:

- Nurse Tank Safety Program and related Nurse Tank Safety Council of Canada Quality Control Manual were updated to reflect the numerous changes within the CSA B620/622 standards. CAAR worked with industry experts and consulted directly with Transport Canada officials to ensure the timely availability of information for program users
- CAAR is in the process of developing additional CSA B620/622 compliance informational materials to ensure that members have access to compliance requirements in an easy to understand format

# **INDUSTRY COLLABORATION**

CAAR's active participation in industry groups, committees and meetings ensure that Canadian ag retailers are represented consistently.

### In 2019-20 CAAR was engaged in:

- CSA B620 and B622 Regulations: Obtained Equivalency and Temporary Certificates ensuring the continued supply of anhydrous ammonia for the spring 2020 season
- CSA Technical Committee: CSA B620 Ag Spec Tank Working Group and leading the creation of a docket for revised Tank Inspector and Tester Qualifications
- Fertilizer Canada Committees: Fertilizer Safety and Security Council; Safety, Training and Transportation of Dangerous Goods; Anhydrous Ammonia Code of Practice, 4R Nutrient Stewardship, Liquid Storage Working Group
- Canada Grain Council: Market acceptance of pesticide use, MRL-related trade risk of chemistry/crop use patterns with new or amended registrations


# THE CAAR CONFERENCE

- · Scholarships to post-secondary ag students


# **TRAINING**
