**Letter of Approval to Anhydrous Ammonia or Fertilizer Distributors.**

This letter of approval includes the operation of any vehicle towing and applicator tank or fertilizer spreader owned by and Anhydrous Ammonia or Fertilizer distributor. **This approval expires December 31, 2025.**

**This letter of approval must be carried by the operator of the towing vehicle and must be presented on the demand of an enforcement officer.**

Anhydrous Ammonia applicator tanks and fertilizer spreaders are approved for highways use pursuant to The Vehicle Equipment Regulations, 1987 when pulled by a registered motor vehicle and operating on a Saskatchewan public road or highway subject to the following conditions:

***Exemption:***

*Section 168 (1) (a) and (b) of The Vehicle Equipment Regulations.*

*- Weight of the trailer and its load may exceed the weight of the towing vehicle if a ball hitch and twice the weight of the towing vehicle if other than a ball hitch;*

*Section 174 of The Vehicle Equipment Regulations.*

*- The vehicle is exempt from being required to be equipped with brakes and brakes that are activated by the brake pedal of the towing vehicle.*

*Section 196 of The Vehicle Equipment Regulations.*

*- The tires are exempt from complying with CMVTSS for highway use.*

*Section 181 of The Vehicle Equipment Regulations.*

*- The vehicle is exempt from being equipped with side marker lamps.*

*Section 168 (2) of The Vehicle Equipment Regulations.*

*- The vehicle is exempt from having to be pulled behind a semi-trailer, gooseneck trailer or a trailer with two or more axles when being pulled in tandem. However this exemption does not extend to towing two anhydrous ammonia tanks in tandem. This is not permitted.*

The applicator tank or fertilizer spreader (empty or with product) shall bear a **slow moving vehicle sign** and towing speed shall be **restricted to a maximum of 40 km. per hour**.

All other equipment requirements with respect to trailers, as per *The Vehicle Equipment Regulations, 1987*, must be in compliance. **This includes**, but is not limited to, **brake, tail and signal lamps** which shall be on the rear most part of the trailer, **safety chains**, a **hitch that must be rated** for the capacity of the towed vehicle, and if applicable, the **draw pin** shall be at least size 5/8 inch grade 8 or rated for the load application and equipped with a **secondary locking device**.

The following minimum configurations of **anhydrous ammonia applicator tanks** and tow vehicles are applicable.

The distributor is responsible to ensure the vehicle operator complies with these conditions when either a distributor's or non-distributor's vehicle is used to tow an applicator tank or fertilizer spreader owned by the distributor.
